

"Emeritus ACHA" Status Policy:

The ACHA Board of Regents, at its discretion, may grant "Emeritus ACHA" status to a certificate holder in good standing who meets all the guidelines outlined below, and pledges to abide by the minimum criteria listed.

Qualifications for Emeritus Status:

"Emeritus ACHA" status is a high honor. This status is granted at the end of one's primary career for years of distinguished service to the Healthcare Architecture profession. In addition to standard immediate retirement, a variety of new options are now available in this new policy update to allow for a phased retirement arrangement. This includes reduced regular hours (part-time), periodic project work (consulting), or significantly changed roles and responsibilities, as a certificate holder transitions over time into full retirement. This policy and application process are not for individuals who plan to maintain their current full-time employment, even if they meet the minimum age or certification requirements.

To become "Emeritus ACHA" will require that an applicant has been **continuously certified in good standing for 15 years minimum and be at least 65 years of age** to qualify. The certification period includes the original year of certification, plus a minimum of 14 years of recertification. If an applicant has already met the minimum of 15 years of continuous certification and is retiring at the beginning of the calendar year in which they will turn the age of 65, an application may be made ahead of the applicant's birth date during that calendar year.

Privileges and Responsibilities of Emeritus Status:

All fees for "Emeritus ACHA" status are waived. However, the former certificate holder is highly encouraged to give back to the College with charitable donations while using the "Emeritus ACHA" credential.

There is no requirement for obtaining continuing education credits, although continuing education is always encouraged. You may continue to maintain all architectural licenses, but none are required.

As a representative of the College with this high honor, individuals holding the title Emeritus ACHA and FACHA are encouraged to be guest speakers, guest teachers, or sit on professional committees of any type that fit within the high ethical standards of the College. We also encourage that you mentor younger architects, assist with AXP courses, or write for professional journals. You are also welcome to apply to serve on ACHA standing or ad-hoc committees, task forces, think tanks, and participate in similar College activities.

This will ensure that the College can communicate with you. If there is no response to this annual e-mail, you may lose this status.
